RESOLUTION AUTHORIZING THE USE OF THE CONSTRUCTION MANAGER-AT-RISK (CMAR) PROJECT DELIVERY METHOD UNDER TEXAS GOVERNMENT CODE CHAPTER 2269 FOR THE NORTH TEXAS MUNICIPAL WATER DISTRICT INTERCONNECTION PROJECT

WHEREAS, RCH desires to utilize the construction manager-at-risk (CMAR) project delivery method to assist and deliver the North Texas Municipal Water District Interconnection for the RCH System (the "Project"); and

WHEREAS, Subchapter F of Chapter 2269, Government Code, "Construction Managerat-Risk Method," describes the construction manager-at-risk method authorized by that subchapter as a project delivery method by which a governmental entity contracts with an architect or engineer for design and construction phase services and contracts separately with a construction managerat risk to serve as the general contractor and to provide consultation during the design and construction, rehabilitation, alteration, or repair of a facility; and

WHEREAS, in relation to the Project specifics and requirements, RHC's staff has considered the methods described in Chapter 2269 and recommends use of the construction manager-at-risk method as the project delivery method that provides the best value for RCH; and

WHEREAS, the RCH Board of Directors finds and deems the Construction Manager-at-Risk Method is in the best interest of, and best value to, RCH; and

WHEREAS, the RCH's staff, with the assistance of the Velvin & Weeks Consulting Engineers, Inc., will be authorized to proceed with the CMAR process described in Chapter 2269 and will return to the RCH Board for award of the Request for Proposal to select the recommended Construction Manager for the Project; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF RCH, THAT:

The RCH Board of Directors hereby finds that with respect to expenditures necessary for the North Texas Municipal Water District Interconnection project, the construction manager-at-risk method described by Subchapter F of Chapter 2269 of the Texas Government Code (Construction Manager-at-Risk) provides the best value and approach for RCH.

The President and General Manager of RCH are hereby authorized to take such further action as may be reasonably necessary to implement the purpose and the provisions of this Resolution.
